Bone Voyage Pet Resort Daycare Waiver

Welcome to Bone Voyage's Daycare Program! Our goal is to promote a safe, positive and social environment for all enrolled dogs. To accomplish this goal and to ensure the safety, health and happiness of all dogs in our care, we require that all pet owners adhere to the following policies. If you have questions or concerns at any time during your dog's enrollment, please do not hesitate to ask us.

I, _____ (Owner[s]), hereby certify that my dog(s),

_____ is/are in good health, have not been ill with any communicable diseases or parasites in the last 30 days, and has/have not harmed or shown aggressive or threatening behavior towards any person or any other dog(s). I also have read and understand the following:

1. I understand there is a one-time evaluation fee of \$25.00 the first day my dog comes to daycare. Dogs participating in daycare must wear a harness at all times. Harnesses may be rented for \$2.00/day.
2. Dogs may be dropped off for daycare any time during business hours. Dogs dropped off in the morning and picked up by noon or dropped off at 2 pm and picked up by 7 pm are charged half-day rates. Otherwise, a full day's rate of \$23.00 is applicable.
3. I understand and agree my dog(s) is/are required to be spayed or neutered by the age of six months to enroll in Daycare.
4. Bone Voyage reserves the right to refuse admittance to any dog(s) or to dismiss any dog(s) that does not meet health, temperament or other Daycare standards. This determination shall be made at the sole discretion of the Bone Voyage Daycare staff.
5. Participating dog(s) must be current on their vaccinations and Bone Voyage must see veterinarian records documenting that records are up-to-date. Required vaccinations are Distemper/Parvo vaccine (1 or 3 year) and Rabies vaccine (1 or 3 year). Bordetella vaccine and a fecal are required once a year.
6. _____ Owner initial.

I understand that during normal dog play, my dog(s) may sustain injuries. All dog play is constantly supervised to avoid injury but injury may still occur despite the best supervision. This includes, but is not limited to, the following:

- a. Communicable illnesses and/or viruses such as Kennel Cough, Canine Influenza, pink eye and/or upper respiratory infections can be transferred among dogs. This is similar to children in daycare where contagious viruses are spread. I further understand that even if my dog(s) has/have been given the Bordetella vaccine, there is a chance that my dog(s) **can still contract Kennel Cough**. I agree I will **not** hold Bone Voyage responsible legally or financially if my dog(s) contracts Kennel Cough or any other illnesses/diseases.
 - b. Injuries, usually minor, such as broken nails, sore pads, sprains, scratches, puncture wounds, abrasions, cuts, etc.
 - c. Spa services, such as bathing, may carry a risk of skin and/or eye irritation and nicks causing bleeding while trimming nails.
7. I understand that should my dog(s) be observed to have fleas and/or ticks while attending Daycare, a flea bath will be given and charged to the owner at the bath rate based on my dog(s) weight plus an additional \$5.00 - \$15.00 depending on weight and degree of infestation.
 8. I understand pictures of my dog(s) may be used by Bone Voyage staff for advertising and promotional materials and social media.
 9. I understand if my dog(s) is/are not picked up within 15 minutes after closing (7:00 pm), Bone Voyage will assume that I am boarding my dog(s) and I will be responsible for the boarding fee.

10. I understand that pre-paid packages are non-refundable. Payment is due and payable at the end of each day. Discount packages are also available. Our program is flexible enough to accommodate reasonable special needs requests.
11. I agree to maintain regular flea and tick preventative programs as long as my dog(s) is/are in regular attendance and participation in Daycare. Heartworm Preventative is also highly recommended.
12. I understand if health and/or behavioral problems develop with my dog(s) that Bone Voyage will not be held liable for any said issues. Furthermore, if health and/or behavioral problems develop with my dog(s), they will be treated as deemed best by the staff at Bone Voyage within their sole discretion, and that I assume full financial responsibility for any and all expenses involved.
13. I understand that in the event my dog(s) appears to be ill or experiencing a medical problem, Bone Voyage will attempt to contact me for instructions prior to seeking veterinary care. If I or the emergency contact cannot be reached or if a medical emergency arises, I agree that Bone Voyage may use its reasonable discretion in seeking veterinary care on my behalf and I will be responsible for all medical bills, boarding and/or any medication costs. I hereby grant Bone Voyage the authorization to treat my pet as the attending veterinarian deems necessary. Medical fees are to be paid in full to Bone Voyage at the time of pick up. Bone Voyage, its owners, employees or agents, will not be held liable for any incidents and/or accidents that may occur in the transport of my dog(s) to or from the veterinarian's office.
14. I agree to hold Bone Voyage, its owners, employees or agents harmless from any claim (including legal fees) for loss of pet(s) by disappearance, theft, death, fire, or otherwise, and from any claim, damage or injury to the dog(s) whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by negligence of Bone Voyage or any parties aforementioned.
15. I understand that attendance of dog daycare is not without risk to myself, members of my family, guests, my dog(s) and/or other dogs, because some of the dogs to which I will be exposed to may be difficult to control and may be the cause of injury even when handled with the greatest amount of care. I hereby release, indemnify and forever hold harmless Bone Voyage, its owners, employees, officers, agents, customers, visitors and guests from any and all liability of any nature, for injury or damage that I or my dog(s) or members of my family or my guests may suffer. This includes specifically, but not limited to, any injury or damage resulting from the action or inaction of any dog or its owner or handler, Bone Voyage, our employees, owners or agents. I expressly assume the risk, negligence or any damage or injury while attending dog daycare or while on the grounds or the surrounding area thereto.

Please tell us anything special we need to know about your dog(s) (i.e., food aggressive, doesn't like certain places touched, jumps/climbs fences, scared of thunderstorms, eats his/her harness, etc.)

By signing this waiver, I state that I have read, understand and agree to the conditions set forth herein this waiver and that I sign voluntarily. This agreement will be in effect for as long as my dog attends Daycare at Bone Voyage Pet Resort. Please sign and date below.
